2. MINUTES

2.1. Adoption of Minutes from April 3, 2024

3. OLD BUSINESS

3.1. Potential Project Discussion

Town Manager Jim Robinson provided quotes on concrete sidewalks, landscaping of town entrance signs coming into town, and the wrapping of electrical boxes. Little Red Wagon estimated \$2,800. Jim stated that Steve Mohr estimated \$2,000 for trees added on. (Teri Reed requested adding a couple of pine trees behind the sign.) Jim informed the commission that the Thrive Center is donating \$500 for banners and requested that the RDC donate \$500 as well. Main Street has asked the town to buy new winter and summer banners. There will also be a couple of school banners added. The town would like to wrap its electrical boxes. He discussed the sidewalk project on Bittner and that it runs from Seifert Creek to the Preserves. There is one bid for that, and we can get a couple more quotes. Clerk-Treasurer Yvonne Jonas said

there is currently approximately \$80,000 in the RDC. Bill Niemier brought up a 50/50 split between town and the RDC for subdivision for sidewalks in Seifert Creek (to be discussed at the town council meeting.)

Ethan Maple moved, seconded by Mark Looney, Motion to invest in those 3 projects - electrical box wrapping, winter & summer banners, and eastside of town entrance signage landscaping.
